This Cookie Notice explains how GCA Law Partners LLP ("GCA") uses cookies and similar technologies on its Website.

What Are Cookies?

Cookies serve different functions on websites, such as allowing you to navigate between pages efficiently, remembering your preferences, and generally improving the user experience.

A cookie is a small text file that is stored on a user's computer for record-keeping purposes. When you visit, access or use the GCA Website, we may – by means of cookies, beacons, tags, scripts, and/or similar technologies – automatically collect technical information. A cookie can generally be classified by its lifespan and the domain to which it belongs.

By lifespan, a cookie is either a session cookie, which is erased when the user closes the browser; or a persistent cookie, which remains on the user's computer/device for a pre-defined period of time.

Generally speaking, there are two types of domains to which cookies belong:

- First-party cookies are set by the web server of the visited page and share the same domain as the visited page.
- Third-party cookies are stored by a different domain than the visited page's domain.

How and Why We Use Cookies

The cookies that we use are essential to the proper functioning of the Website, and cannot be switched off in our system. These are known as "strictly necessary" cookies, and this includes cookies that capture and store users' preferences, account settings, and certain login information (mainly for convenience, user verification, and account security). These cookies typically are set in response to actions made by you, such as a request for access to our Website, setting your privacy preferences, logging in or filling in forms.

Cookies We Use

GCA uses the following first-party cookies on the Website:

_ga	This cookie is installed by Google Analytics. The cookie is used to calculate visitor, session, campaign data and keep track of site usage for the site's analytics report. The cookies store information anonymously and assign a randomly generated number to identify unique visitors.	Analytics	2 years
_gid	This cookie is installed by Google Analytics. The cookie is used to store information of how visitors use a website and helps in creating an analytics report of how the wbsite is doing. The data collected including the number visitors, the source where they have come from, and the pages viisted in an anonymous form.	Analytics	1 day
_gat	This cookies is installed by Google Universal Analytics to throttle the request rate to limit the collection of data on high traffic sites.	Performance	1 minute
